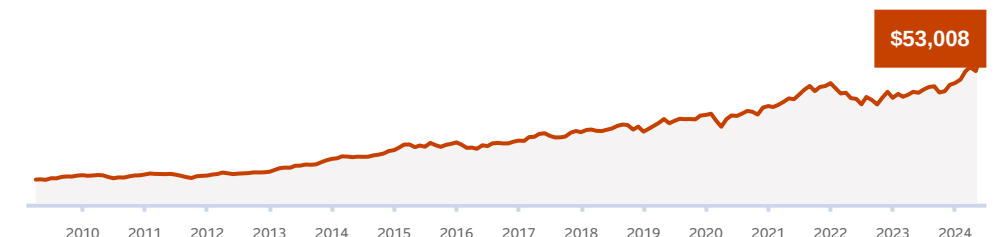


## Sun GIF Solutions Sun Life MFS US Equity Investment Series A
