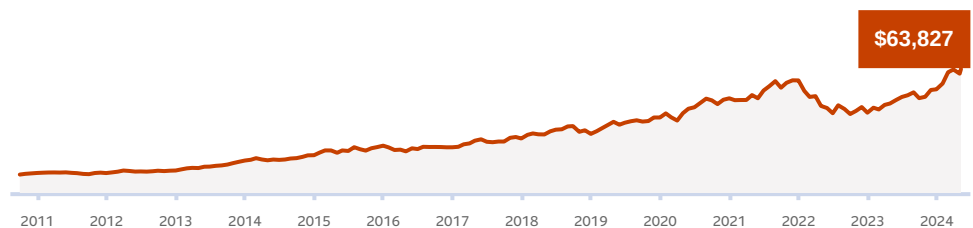

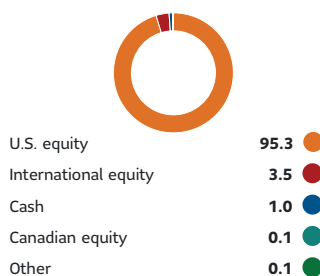

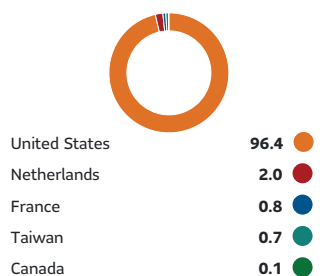
### Asset allocation

% as of Feb 29, 2024



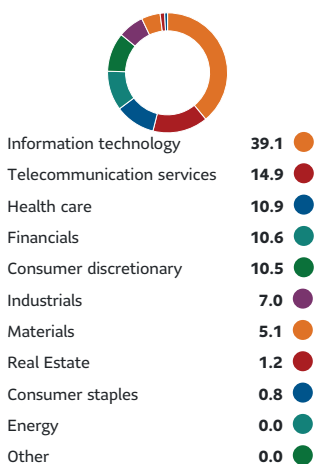
### Geographic allocation
