## You asked, we answered

### 1. Where on [mysunlife.ca](https://mysunlife.ca) can I access the planner?

You can access the new Retirement Planner on [mysunlife.ca](https://mysunlife.ca). When you visit the Retirement Planner, you'll be directed to the latest tool. If you previously used Sun Life One Plan, you'll automatically continue to use that same tool. Sun Life One Plan is more comprehensive than the new Retirement Planner.

### 2. What if I haven't used Sun Life One Plan?

After logging into [mysunlife.ca](https://mysunlife.ca) and navigating to the Retirement Planner, you'll first be presented with the new Retirement Planner. You can complete the new Retirement Planner and then continue to Sun Life One Plan. Or you can go directly to Sun Life One Plan by clicking on the available links while you're using the Retirement Planner.

### 3. If I need help filling out Sun Life One Plan, will there be a guide to support me?

Yes. You'll see a question mark symbol that describes what the fields contain and what information the tool is looking for. You can also get one-on-one support anytime with 360 Plan Advice from a Sun Life financial services consultant (registered as a financial security advisor in the province of Quebec).



#### 4. Why did Sun Life change the planner?

The new planner provides a more personalized retirement planning experience. With the new approach, your plan will combine all your Sun Life savings into one view. It'll also include the latest Canada Pension Plan (CPP), Quebec Pension Plan (QPP) and Old Age Security (OAS) program enhancements and detailed tax calculations.
